# DECEMBER 2018 MEETING FOR BUSINESS MINUTES

## Corvallis Monthly Meeting for Business Minutes

**Meeting began** with expectant silence. The clerk read these queries from NPYM Faith and Practice:

- Do we each take an active part in the life of our meeting? In what ways do we grow by participating in the life of the meeting?
- Do we provide youth with responsible opportunities and encouragement to participate in meeting life and structure?
- Do we express our skills and gifts in service to the meeting and to the Spirit? Do we recognize and support others in doing so?
- How do we welcome and involve newcomers?
- How do we encourage attenders from all ethnicities, backgrounds, and faith perspectives to share in the life of the meeting? Do we urge them to consider membership when they are ready?

**November Minutes** were approved as published in the newsletter

**The Pre-Nominating Committee** of John Selker and Bob Ward recommend Bob Burton to serve on the Nominating Committee from January 2019 to December 2021. Bob Ward asked that the Meeting approve this nomination today without the usual month of seasoning in order for the committee to start work earlier. Meeting approved.

The Committee also noted that many regular attenders and newer Members lack knowledge, experience, and/or confidence in their

understanding of Quaker business practices. After some discussion, Meeting approved the formation of a small group to consider ways to approach this problem and approved Wendy Robinson, Bob Burton, Esther Schiedel and either Bob Ward or John Selker to this group.

**Nominating Committee** clerk, Lisa Yagoda, reported that they are not ready to name an additional member to Spiritual Care Committee at this time. She suggested that the Spiritual Care Committee might find support in other ways in addition to adding another member. Bob Burton, the only member of the Spiritual Care Committee present, agreed that other or outside support is a good idea.

**Treasurer's** Report was accepted with gratitude. Wendy noted that we were able to make all our yearly donations to various groups.

**Adult Religious Exploration** (Bob W. and Judy reporting) recommended that the Third Age Circle become a self-organized group, releasing the ARE members to take on another need or priority of CFM. The group will remain an open circle – we encourage any and all Friends to join in at any stage. Meeting approved.

The Third Age Circle Group requested:

1. Use of the Fellowship Room for our monthly sessions and subgroup meetings on Wednesday late afternoons.
2. Permission to rotate a key among the people who will convene the sessions. Over half the regular participants already have keys, so this may just be a formality.
3. Budgeting a reasonable sum - \$100.00 is suggested -- within the Library fund or SCC for practical books and resources on Third and Fourth Age. These will live in the library for everybody in the Meeting and their families to learn and prepare for later life.

Meeting approved these requests.

A small worship sharing subgroup has formed.

## Advices and Queries on Home and Family

Live in the assurance that all are children of God.

Hospitality in the home is a vital force for spiritual nurture; it helps all family members learn to respond to that of God in everyone.

Know that a family may be made of single adults, of differing combinations of adults, or of adults and children, sharing a bond of love. Meeting provides an essential sense of family for those without families, including those made single after years of marriage or other life commitment.

We give home and family priority in our lives.

The meeting can support, yet cannot replace, the family in the care of children. At the same time, every member of meeting is responsible in some measure for the care of families, including children.

Stay aware of the many ways the meeting can act as a family-and the ways it cannot.

Be both bold and tender in offering assistance to families that may be experiencing discord or domestic abuse.

- How do we make our homes places of friendliness, peace, and renewal, where Spirit is real for those who live there and those who visit?
- How do we maintain a climate of love and trust in our meeting which invites families to be open about their satisfactions and challenges?
- How do we keep commitments outside the home from encroaching on the time and loving attention the family needs for its health and well-being?
- Does our home life support our need for both a sense of personal identity and shared living?
- What supports do we offer to the aging, the widowed, the separated or divorced, and members of families affected by disruption or trauma?
- How does the meeting assist families to improve communication, family life, and the rearing of children in a context of love?
