November 13, 2022

**The Meeting opened with a period of expectant quiet.**

**Minutes of the October meeting:**

Approved.

**Treasurer's Report:**

Though the Treasurer was not able to be present, she had prepared both the November 13, 2022, monthly report, together with an analysis of the Meeting's current financial situation, and a comparison of the 2022 budget with actual expenses through October.

As it was not listed in the report, there was a question as to whether the "Family Crisis Fund" that was approved at the October Meeting for Business had been established. It is the Clerk's understanding that the fund has been established, and funds are being collected.

In response to a question at the October Meeting for Business on how the Meeting is doing with regard to the budget, the Treasurer reported that income received is about \$7,000 short of our budgeted income for the year. It was mentioned that some expenses budgeted (e.g., childcare) have not yet been needed or fully used. The Meeting normally makes its donations in December. Waiting until after the December Meeting for Business to authorize donations will enable the Meeting to assess the financial situation at that time. The same as for most other investments in the stock market, there has been a loss in the value of the Meeting's brokerage account with Friends Fiduciary.

This report was accepted with thanks, with the one question being as to whether the "Family Crisis Fund" has officially been set up.

**Spiritual Care Committee Report:**

Jay Thatcher presented the report from the Committee's meeting last week.

The Meeting does not have enough hosts in the meeting room for hybrid worship. If anyone is inclined to help in this regard, they should speak with Abigail Stoughton or Jay Thatcher. Training and encouragement are available.

The way forward for integrating virtual worship with those who gather in-person is not clear. The Committee plans to schedule a threshing session, primarily with Zoom attendees, to listen to frustrations, ideas, and hopes for maintaining a strong connection to the Meeting as a whole. How can we be tender with each other while sorting through the knotty issues? Are there other ways we can promote inclusion?

The donated meeting room computer no longer functions. The Committee requested that \$500 be made available to purchase a computer for use at the Meeting House. The ad hoc committee on information technology would consult with SCC to make some choices for this. In addition to making hybrid Meeting for Worship possible, the Meeting discussed additional ways the equipment and internet connection can be, or has been, used; this includes possibilities for the youth program, the FCNL Advocacy Group, the Spiritual Care Committee, and other outreach and education.

This request was approved.

SCC routinely considers the various needs of many Friends in the meeting. In order to meet some of them, it anticipates seeking volunteers to help:

- provide meals after surgery;

- make friendly visits to Friends in a couple of retirement centers;
- drive a Friend or two to Sunday worship;
- serve as a touchstone or buddy to people who are new to our meeting.

The Committee's next meeting will be on the afternoon of 12/7/2022.

#### **Nominating Committee Report:**

Nina Joy Lawrence reported that an additional member of the Committee is needed for a full complement of three people. Currently Nina Joy and Carmen Brummet serve on this committee. Committee members are nominated by a "pre-nominating committee". When asked for volunteers for the pre-nominating committee, Jay Thatcher and Susan Easton agreed to serve. The Nominating Committee would like to have a full committee by January.

-How does the Spirit guide us in our relationships to money? How do our choices reflect the working of Truth and Love in our lives and in the world?


-How do we avoid judging others, and ourselves, by worldly criteria of wealth or status? How do we answer to that of God in those who have less than we do? in those who have more than we do?
