Treasurer’s Report

CFM charity donations are made in December every year. Donations to the various organizations are also possible directly from individuals.

POP is a pass-through account enabling donations to fill propane tanks for unhoused persons. Tanks filled last week ahead of the ice storm ran to over \$700. At this rate, there are enough funds in the account to carry the program into early March.

Insurance is carried through Church Mutual Co. It includes liability insurance for sexual assault/abuse, theft, and coverage of the building. Their web site explains in detail what is covered.

FWCC is under the umbrella of Right Sharing Excess funds are held in the Friends Fiduciary account. It received a 4% dividend (\$270.38) which was automatically reinvested into the fund. It had an increase in market value of \$1,212.41.

The year end balance of 2022 was \$9000; the year end balance of 2023 was \$12,805.

Treasurer thanked Bob Ward for his work in building an Excel program for tracking the treasurer’s files and databases.

The meeting accepted the treasurer’s report.

Treasurer’s Budget Report for 2024

Highlighted points:

- There is a small differential between donations and expenses.
- There is no budget item to set aside money for emergency expenses. One Friend noted that we used to have a Needs Arising category.

- Water expenses from the city are increasing.
- Input for budget is requested from the Library Committee and from the Children's Program.
- Childcare expenses were left in the budget although they are not currently being used. The Children's Volunteer Coordinator is working on developing the program.
- Input was requested of the Adult Religious Education Committee (ARE) regarding CFM reparations for the native land CFM sits on.
- ARE budget only shows expenses for Welcoming Friends, but no other programs.
- At a previous threshing session, Friends supported applying most of CFM donations locally. This budget funds \$10,000 directly to Corvallis charities (total=\$12,400).
- One Friend noted that in past years, CFM endeavored to achieve equity between expenses and donations. This budget funds CFM expenses at \$17,533 and charitable donations at \$12,400.

Meeting will season the projected budget until next Meeting for Business.

Prenominating Committee Report

No name was put forward to fill the nominating committee vacancy.

Spiritual Care Committee (SCC) Report

SCC and Friends are still seeking better ways to worship together. Friends are encouraged to speak individually to SCC members with their concerns. Resulting from these conversations, SCC feels that:

- Two hybrid meetings per month on the 2nd and 4th Sundays are appropriate.
- On the 3rd Sunday, Walking Worship should start from the Meeting House at 10 am, and return in time to join Meeting for Worship at the Meeting House for closing and announcements, followed by potluck.
- There are several technical things to try for dealing with Hybrid Worship issues.
- There should be a meeting between the people who host Hybrid Worship and Virtual Worship to explore suggestions for change.
- The chairs in the Meeting Room will be arranged in a horseshoe layout, facing the screen, with a second row of chairs behind, offset so faces can be seen on the screen. There will still be places where people who do not want to be seen on the screen can sit.
- The next SCC meeting planned for February 7, 2024.

Meeting accepted the SCC report.

Adult Religious Education (ARE) Committee Report

ARE held a workshop January 7, 2024. Participants brainstormed practical steps toward restoring right relations with indigenous people. ARE intends to facilitate a 2nd Hour program February 4, 2024 to further explore tangible action(s). A request was made to look at the list of suggestions brainstormed. **Clerk of the Meeting will make a list available.**

ARE invites Friends to join a January 28, 2024, 2nd program exploring our journey in

“Becoming Friends.” The focus will particularly be on newcomers, while helping experienced/seasoned Friends share and explore ways to further this journey.

Meeting accepted the ARE report.

Grounds Report

A grounds volunteer has suggested changes to the back yard of the Meeting House (northwest corner). The grass under the grape arbor is hard to mow, without pruning back the arbor, which takes extra time and attention. Suggestions and comments:

- Pull out the grapes.
- Commit to keeping the grapes pruned back and mulched.
- Comments both supported keeping the long-lived grapes and taking them out.
 - The grapes have sentimental value to many Friends, though many are willing to forego them.
 - It is nice to have a fresh, sustainable snack available.
 - Some feel the grapes are extremely delicious; others feel they are not tasty at all.
- Build a meditation area (bench/benches, landscaping/hardscaping). The cherry and persimmon trees (and one other tree), will get bigger, affecting the use of the area.
- There is no railing around the steps and platform opening from the Meeting House exit. Although the city does not require a railing in this particular circumstance, several Friends thought a railing would make the steps safer to use.
- A visioning statement for the entire grounds of the Meeting House, should be

undertaken, so that decisions aren't made piecemeal.

Clerk of the Meeting suggested a threshing session which was agreed. A time and date will be announced at a later date.

The next Meeting for Business will be on February 11.

A written **Treasurer's Report** was provided. Wendy noted that contributions included a donation to the Propane supply project which is an earmarked account. **Treasurer's Report was accepted with gratitude.**

Report from the Spiritual Care Committee:

As a recent threshing session concluded, Friends knew there were others we still needed to hear from. The Spiritual Care Committee (SCC) is now having conversations with a couple of handfuls of Friends with hopes to gain a wider perspective on hopes, preferences and needs for how and where to hold worship. They invited Friends with something to add beyond what was shared during threshing, to offer perspectives to a Friend from the SCC. The next steps seem to be to continue these conversations with other Friends, then collect specific ideas from the threshing and these conversations for SCC to consider in the new year.

Following a **suggestion from over a year ago to consider making two committees, one for pastoral care and one for helping foster worship and ministry in the Meeting.** The Spiritual Care Committee has united on this prospect. This could leave the latter committee free to continue addressing the issues posed by our recovery from shuttering the Meeting House on Sundays while providing for more thorough and comprehensive attention to the pastoral needs within the Meeting. **The Meeting approved and asked Nominating Committee to implement this with the new terms of office.**

Next Spiritual Care Committee meeting is planned for 1/10/2024.

Prenominating Committee: Meeting approved Laura Horsey and Dana Edwards as a committee to nominate the next person to serve on Nominating Committee.

This one is different because it is much more than a history of 300+ years of white, English, American Quaker men & women. America. It shows, "some new facets of what it means to be in Quaker community." It is an example of "making the road while walking it." Of how Quakers are living "in the world" while resisting its values.

It is "less an introduction to the seasoned Quaker than it is an invitation to truly live with Quakerism . . . in diverse communities all over the world."
