**Minutes of April 14, 2024 Meeting for Business were approved.**

### **Treasurer's Report(s)**

The Assistant Treasurer noted two corrections to the April, 2024 Treasure's Report.

Left off was a \$10,000 donation

A deposit of \$584.25 was uncategorized, but presumed to be rent.

Notations for the May report are:

A larger amount for electricity due to malfunctioning thermostat,

Meeting supplies in the amount of \$51.48 were donated to Meeting,

The POP program is finished for the year. Over the heating season, \$12,516 was donated.

### **Request for Hosting WQM Spring 2025**

Clerk stepped aside. Jay Thatcher stepped in to clerk the discussion. Bob Burton and Bob Ward spoke on behalf of the opportunity for CFM to host the Willamette Quarterly Meeting (WQM) in May, 2025. They noted that Quarterly Meeting is an old tradition that facilitated Quakers from the region to join in fellowship with each other. Our region includes Meetings in the Willamette Valley, the Oregon Coast, the Oregon/Washington border, the Cascades, and Boise. It has also been an

opportunity for Quaker youth to enjoy a relationship with their Quaker peers. This is an opportunity for the new attenders in our midst to learn more about how Quakers function, and to get to know Friends outside CFM.

FWCC (Friends World Committee for Consultation) is getting ready to launch an initiative to deepen relationships between Quakers worldwide and to revitalize Quaker meetings. This could be an opportunity to tie into that initiative.

The Quarterly Meeting traditionally met Saturdays, quarterly, but in recent years changed to meeting yearly for a weekend retreat. The host responsibilities rotated among Eugene, Corvallis/Salem, and Portland meetings. We are now being asked to host the 2025 WQM.

It is expected that task lists from this year and last year will be available for our guidance.

Responsibilities would be shared with volunteer coordinators from WQM, but we would be responsible for:

- Deciding on a theme for the retreat,
- Providing a Clerk for the WQM Meeting for Business,
- Finding and arranging a venue to hold 60-100 people,
- Organizing the retreat spaces and providing volunteers to arrange spaces,
- Organizing meals,
- Organizing lodging for those needing it.
- Bob W and Bob B have agreed to coordinate CFM volunteer efforts. Several people volunteered to help with the planning and implementation as they are able including Donna Gerry, John Selker, Bob Henderson, Kathy Miller, and Esther Schiedel. It is anticipated that other volunteers will step up

and that volunteers from other meetings will also help out.

**\* Meeting minuted its acceptance of taking on host responsibilities for WQM in May of 2025.**

## Advices & Queries Stewardship of Money & Other Resources (part 2)

We accept our gifts and recognize with profound gratitude any opportunities to share them generously. We embrace and uphold Friends commitment to improving the human condition with all available gifts.

- How do we avoid judging others, and ourselves, by worldly criteria of wealth or status? How do we answer to that of God in those who have less than we do? in those who have more than we do?
- How do we use the gifts we are given in ways that build community and bring us closer to the Source and Center?
- What is our “fair share”? How do our social and economic choices help or harm our vulnerable neighbors – human and non-human? Can we identify “the seeds of war” in our choices?



### **Advices & Queries: Expectant Worship, Vocal Ministry**

We prepare ourselves for meeting for worship in many ways – for example, through regular study, meditation and prayer – so that we come into meeting with open, expectant spirits seeking after Truth.

Search within yourself before rising to give vocal ministry – be aware of the physical and spiritual promptings that underlie true vocal ministry.

***If prompted by the Spirit to give vocal ministry, we speak audibly, clearly, simply, and as briefly as possible.***

Listen to the ministry of others as if it is the voice of the Divine; seek the thoughts behind the words and hold the speaker in love.

After a message is given, Friends take time to ponder its meaning and to give space before rising to speak if we are so led.

Prepare the children of meeting to understand and experience the power of Quaker worship and vocal ministry.

- How do we prepare our hearts and minds for meeting for worship?
- Do we worship together in a way that honors and respects other Friends’ beliefs? How do we listen to ministry that seems wrong or misguided?
- Do we meet for worship in expectant waiting for the promptings of the Divine Spirit? How do we carry this inspiration into our daily living?
- How do we take care that our vocal ministry is not lightly given? Do we offer vocal ministry under the leading of the Spirit, in the simplicity and sincerity of truth?
- As we listen, or as we speak, are we guided by the inward Light and sensitive to one another’s needs? Are we careful not to speak at undue length or beyond our call?
